1. Contains bovine penis (pizzles) as the only animal origin.
2. Produced only in Bangladesh.
3. Material: derived only from bovines that: (a) have never been fed ruminant derived meat-and-bone meal and greaves, AND (b) were not subjected to a pitching process or a stunning process using a device injecting compressed air or gas into the cranial cavity.
4. Heated to a temperature of 80° C for 2 hours.
5. The product has been tested at Central Disease Investigation Laboratory (CDIL) Dhaka, under the Directorate of Research, Training & Evaluation of DLS and found no Salmonella spp were found from thr collected Pet food/chews/treats (Bovine pizzle/penis) during the period of examination according to the report No.1433 Date- 22/09/2021.
