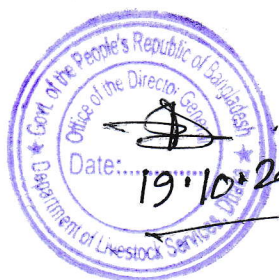
TO WHOM IT MAY CONCERN

Department of Livestock Services, Bangladesh, Dhaka has no objection to allow Bangladesh Army to import 15(Fifteen) live horses from Indian Army as a gift from India to Bangladesh by road, provided that the consignment would be as per international regulation in force.

After arriving the horse must be inspected by Quarantine officer at Quarantine station, Benapole, Sharsha, Jashore, Bangladesh and would be reported to our Quarantine officer 7days prior to arrival.
