| 2.3 | Bovine bone granules are obtained from animals that were slaughtered in the officially approved slaughterhouse and were subjected to ante and postmortem examination and did not show any sign of infections or contagious diseases. | |
| 2.4 | Bovine bone granules were processed in the establishment approved by Ministry of Industries, Bangladesh with the consent of DLS and under supervision of DLS. | |
| 2.5 | Bovine bone granules were undergone heat treatment at least 90°C for 120minutes. Under the stated above department of Live Stock Services (DLS) shall be responsible authority for the quarantine and Inspection of bovine bone granule exported to China From Bangladesh. | |
| 2.6 | The Product has been tested at Central Disease Investigation Laboratory (CDIL), Dhaka and found negative for Anthrax According to CDIL Report No. 2314 , Date: 24/11/2019 | |
