Department of Livestock Services, Bangladesh, Dhaka has no objection to allow M/S Rifa Enterprise, 51, North Goran (2nd Floor), Dhaka-1219, Bangladesh to bring 10(Ten) live pet dogs from The Netherlands to Bangladesh by air for using in Bangladesh Rapid Action Battalion Forces Headquarters, Kurmitola, Dhaka-1229, provided that the consignment would be as per international regulation in force. Dogs must be quarantined 28 days under custody of importer. It should be regular inspected by the Quarantine Officer, Quarantine station, Hazrat Shahjalal International Air Port, Dhaka and Veterinary Officer, Rapid Action Battalion Forces Headquarters Dog Squared, Dhaka. On the basis of medical report of veterinarian measure should be taken and it should be reported to the undersigned officer.

After arriving dogs must be inspected by Quarantine officer at Quarantine station, Hazrat Shahjalal International Airport, Dhaka, Bangladesh and would be reported and submitted vaccination record and health certificate to the undersigned officer within 7 days.
