- b) brain, skull, eyes, trigeminal ganglia, spinal cord, dorsal root ganglia, and vertebral column (excluding the vertebrae of the tail, the transverse process of the thoracic and lumbar vertebrae, and the wings of the sacrum) from bovines 30 months of age and older; and

2) From Undetermined Risk Regions:


- a) the distal ileum of the small intestine and the tonsils from bovines of any age, and b) brain, skull, eyes, trigeminal ganglia, spinal cord, dorsal root ganglia, and vertebral column (excluding the vertebrae of the tail, the transverse process of the thoracic and lumbar vertebrae, and the wings of the sacrum) from bovines older than 12 months of age.


BSE controlled risk regions as recognized by APHIS are: Canada, Costa Rica, France, Germany, Greece, Ireland, Lithuania, Mexico, Nicaragua, Poland, Spain, Switzerland, Taiwan, and the United Kingdom.

BSE negligible risk regions as recognized by APHIS are: Argentina, Australia, Austria, Belgium, Brazil, Bulgaria, Chile, Colombia, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, Hungary, Iceland, India, Israel, Italy, Japan, Republic of Korea, Latvia, Liechtenstein, Luxembourg, Malta, The Netherlands, New Zealand, Norway, Panama, Paraguay, Peru, Portugal, Singapore, Slovakia, Slovenia, Sweden, and Uruguay.

Regions not listed as either negligible or controlled risk are recognized as undetermined risk.
