1.	contains bovine pizzles as the only animal origin material ;
2.	was produced only in Bangladesh ;
3.	Contains bovine material derived only from bovine that: a) have never been feed ruminant derived meat-and-bone meal and greaves, AND b) were not subjected to a pitching process or a stunning process using a device injecting compressed air or gas into the cranial cavity;
4.	was heated to a minimum temperature of 85 ° C for 60 minutes; and
5.	was produced and handled in a manner to ensure that such commodities were not commingled with any animal origin material not authorized by this permit including ruminant meat-and-bone meal, greaves, SRMs [described below], and mechanically separated meat derived from the skull and vertebral column of bovines 30 months of age or older from APHIS-defined controlled risk regions or bovine over 12 months of age from APHIS-defined undetermined risk regions [BSE regions described below].



SRMs only apply to Controlled and Undetermined Risk Regions and include the following list, as recognized by APHIS:

1) From Controlled Risk Regions:

- a) the distal ileum of the small intestine and the tonsils from bovines of any age, and
- b) brain, skull, eyes, trigeminal ganglia, spinal cord, dorsal root ganglia, and vertebral column (excluding the vertebrae of the tail, the transverse processes of the thoracic and lumbar vertebrae, and the wings of the sacrum) from bovines 30 months of age and older; and

2) From Undetermined Risk Regions:

- a) the distal ileum of the small intestine and the tonsils from bovines of any age, and b) brain, skull, eyes, trigeminal ganglia, spinal cord, dorsal root ganglia, and vertebral column (excluding the vertebrae of the tail, the transverse processes of the thoracic and lumbar vertebrae, and the wings of the sacrum) from bovines older than 12 months of age.

BSE controlled risk regions as recognized by APHIS are: Austria, Belgium Brazil, Canada, Colombia, Cyprus, Czech Republic, Estonia, France, Germany, Greece, Hungary, Ireland, Italy, Japan, Latvia, Lichtenstein, Lithuania, Luxembourg, Malta, Mexico, the Netherlands, Poland, Portugal, Republic of Korea, Slovak Republic, Slovenia, Spain, Switzerland and the United Kingdom.

BSE negligible risk regions as recognized by APHIS are: Argentina, Australia, Chile, Denmark, Finland, Iceland, New Zealand, Norway, Panama, Paraguay, Peru, Sweden and Uruguay.

Regions not listed as either negligible or controlled risk are recognized as undetermined risk.

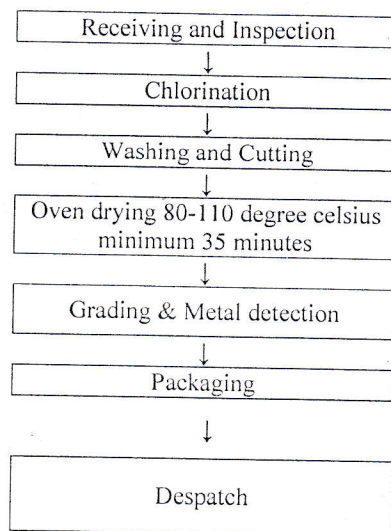
