The slaughterhouse where the animals were slaughtered and Processing plants where the meat and meat products were packed are approved and under regular veterinary-sanitary supervision of the competent veterinary authority.

2. The meat and meat products were derived from animals that underwent ante and post mortem inspection and did not show signs of infectious and contagious diseases at the time of slaughter.

3. The meat and meat products havebeen subject to the testing programmes for harmful organisms administered by the supervision of Upazilla Livestock officer, Santhia, Pabna, Bangladesh and found no *Salmonella* and *Anthrax* organism. On the other hand *E.Coli* found within the tolerable limit.

4. The meat and meat products herein described have been dressed, prepared and packed under hygienic conditions in officially approved establishments The meat and meat products are fit for human consumption.
