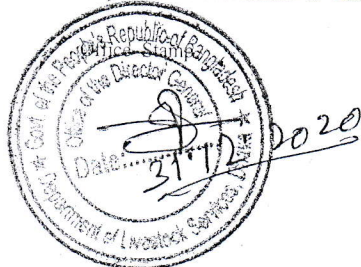



This is to certify that Chomchom-960Kg, Kalojam Sweet-480 Kg, Rosogolla Sweet-480 Kg, Mix Sweet-480 Kg, Curd- 3600 Kg, Roshmalai-1800 Kg, Kheer Chomchom-960 Kg, Nolen Gurer Sondesh-480 Kg, Chana Sondesh-480 kg, are the milk products in the exported material are the only animal origin ingredient and the milk products in the exported material was heated to a minimum temperature of 72^oc for 15 seconds followed by a second heating to a minimum temperature of 72^oc for 15 seconds and a single pasteurization of 72^oc for 15 seconds followed by a pH treatment of less than 6 for a minimum of one hour prior to exportation to the United States. The samples of said products were examined in Central Disease Investigation Laboratory (CDIL), Dhaka under the Directorate of Research, Training & Evaluation of Department of Livestock Services and no bacteria and fungus identified in supplied samples during the period of examination (Report no-4092, date: 24.12.2020). This certificate is valid for 90 days from the date of issue.
