

Contains bovine penis (pizzles) as the only animal origin material.</li><li>2. was produced only in Bangladesh.</li><li>3. Contains bovine material derived only from bovines that: (a) have never been fed ruminant derived meat-and-bone meal and greaves, AND (b) were not subjected to a pithing process or a stunning process using a device injecting compressed air or gas into the cranial cavity.</li><li>4. was heated to a minimum internal (core) temperature of 80<sup>0</sup> C and</li><li>5. was produced and handled in a manner to ensure that such commodities were not commingled with any animal origin material not authorized by the USDA permit (C-127756 commercial) including ruminant meat-and-bone meal, greaves and mechanically separated meat derived from: a) the skull and vertebral column of bovines over 12 months of age b) the distal ileum of the small intestine and the tonsils from bovines of any age; c) brain, skull, eyes, trigeminal ganglia, spinal cord, dorsal root ganglia, and vertebral column (excluding the vertebrae of the tail, the transverse processes of the thoracic and lumbar vertebrae and the wings of the sacrum) from bovines older than 12 months of age.</li><li>6. The product has been tested at Central Disease Investigation Laboratory (CDIL) Dhaka, under the Directorate of Research, Training &amp; Evaluation of DLS and found negative for Salmonella spp. according to the (Report No: 640 date- 28/4/2021).</li></ol> <p><b><u>BSE FREE CERTIFICATION</u></b></p> <p>It is certified that, "Bovine Spongiform encephalopathy (BSE) is not reported in Bangladesh. The products described above have been derived from the Bangladeshi Buffaloes/Bull, Further these products have not been derived from the material associated with the products imported from BSE/TSE affected countries, through importation of live cattle, buffalo, sheep and goat bovine, ovine and caprice embryo/oval fresh meat, meat products tissue/organs, meat and bone meal of ruminants origin into Bangladesh.</p>
