7. The poultry from which washed feather derived are born and raises in exporting country. No poultry are contained or killed for epidemic disease reasons.
8. The raw feather material should be originated from abattoir which under the supervision of exporting country competent authority.
9. The feather washed, then dried at a temperature of 120°C for at least of 30 minutes, or treated with hot steam of 100°C for at least of 30 minutes.
10. Washed feathers are clean, dry, free of blood stains, faces and evident skin pieces.
11. Oxygen consumption $\leq 5.6\text{mg}/100\text{g}$, transparency $\geq 500\text{mm}$.
12. The product has been tested at Central Disease Investigation Laboratory (CDIL) Dhaka, under the Directorate of Research, Training & Evaluation of DLS and no bacteria and fungus identified in supplied washed gray duck feather samples during the period of examination according to the (Report No. 2349 date- 29/12/2021).
