CERTIFICATION:

In so far as can be determined and based on written declaration of the exporter I, the undersigned official veterinarian certified that the material:

1. Contains bovine penis (pizzles) as the only animal origin.
2. Produced only in Bangladesh.

3. Material: derived only from bovines that: (a) have never been fed ruminant derived meat-and-bone meal and greaves, AND (b) were not subjected to a pitching process or a stunning process using a device injecting compressed air or gas into the cranial cavity.
4. Heated to a temperature of 80⁰ C for 60 minutes.
5. The product has been tested at Quality Control Laboratory (QC-Lab), Savar, Dhaka of DLS and found negative for Salmonella spp. according to the Certificate of Analysis. (Report No: QCLab_DLS_22040110, Date-28/05/2022). This certificate is valid for 90 days
