

The milk products in the exported material was heated to a minimum temperature of 72⁰c for 15 seconds followed by a second heating to a minimum temperature of 72⁰c for 15 seconds and a single pasteurization of 72⁰c for 15 seconds followed by a pH treatment of less than 6 for a minimum of one hour prior to exportation to the United States. 3. 
