



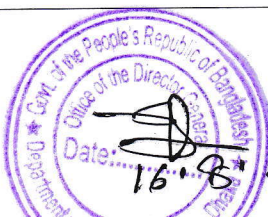

In so far as can be determine and based on written declaration of the exporter I, the undersigned official veterinarian certified that the material:


1. The poultry from which washed feather derived are born and raises in exporting country. No poultry are contained or killed for epidemic disease reasons.
2. The raw feather material should be originated from abattoir which under the supervision of exporting country competent authority.
3. The feather washed and then dried at a stream temperature of 120°C for at least of 40 minutes from July 11, 2022 to July 13, 2022.
4. Washed feathers are clean, dry and free of blood stains, faces and evident skin pieces.
5. The product has been tested at Quality Control Laboratory (QC-Lab), Saver Dhaka under the Department of Livestock Services (DLS) and found no Salmonella spp identified in supplied Pre-washed Grey duck feather (Separated) samples during the period of examination according to the (Report No. QCLab\_DLS\_22070015 Date: 21/07/2022).
