



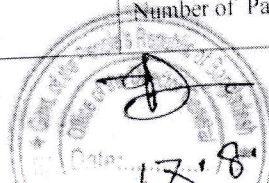



Material: derived only from bovines that: (a) have never been fed ruminant derived meat-and-bone meal and greaves, AND (b) were not subjected to a pitching process or a stunning process using a device injecting compressed air or gas into the cranial cavity.</li><li>4. Every Precaution was taken to cross-contamination of the finished product with any animal origin product or by-product derived from animals of a lesser zoo sanitary status.</li><li>5. The Pet chews are packaged in new packaging material.</li><li>6. Exported Product Heated to a minimum internal temperature of 85° c for a minimum of 5 hours.</li><li>7.
