

The poultry from which washed feathers derived are born and rises in exporting country. No poultry are contained or killed for epidemic disease reasons.</li> <li>2. The raw feather material should be originated from an abattoir under the supervision of exporting country's competent authority.</li> <li>3. The feather was washed, then dried at a temperature of 120<sup>0</sup>C for at least 30 minutes, or treated with a hot stream of 100<sup>0</sup>C for at least 30 minutes.</li> <li>4. Washed feathers are clean, dry, and free of blood stains, faces, and evident skin pieces.</li> <li>5. Oxygen consumption <math>\geq 5.6\text{mg}/100\text{g}</math>, transparency <math>\square 500\text{mm}</math>.</li> <li>6. The product has been tested at Quality Control Laboratory (QC-Lab), Saver Dhaka under the Department of Livestock Services (DLS), and found no Salmonella spp. identified in supplied cleaned duck feather samples during the period of examination according to the (Report No. QCLab_DLS_22080049 Date: 31/08/2022)</li> </ol>
