

Heated to a temperature of 120⁰ C for 4 days. 5. The product has been tested at Quality Control Laboratory (QC-Lab), Savar, Dhaka Under the Department of Livestock Services (DLS), and found no Salmonella spp. & other Enterobacter spp. (E. Coli) within permissible limits according to the Certificate of Analysis.
