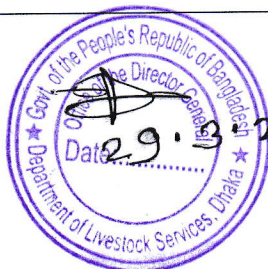

**CERTIFICATION:**

In so far as can be determined and based on written declaration of the exporter I, the undersigned official veterinarian certified that the material:

1. Contains bovine penis (pizzles) as the only animal origin Ingredients and does not include bones or tails.
2. Produced only in Bangladesh.
3. Material: derived only from bovines that: (a) have never been fed ruminant derived meat-and-bone meal and greaves, AND (b) were not subjected to a pitching process or a stunning process using a device injecting compressed air or gas into the cranial cavity.
4. Every precaution was taken to prevent cross-contamination of the finished product with any animal origin product or by-product derived from animals of a lesser zoo sanitary status.
5. Heated to a temperature of 85°C for 5 Hours.
6. The pet chews are packaged in new packaging material.
7. The product has been tested at Quality Control Laboratory (QC-Lab), Saver Dhaka of Department of Livestock Services (DLS) and found no Salmonella spp. & other Enterobacter spp. (E. Coli) within permissible limit according to the Certificate of Analysis. (Report no: QCLab\_DLS\_22090019 Date: 15/09/2022) during the period of examination.

**BSE FREE CERTIFICATION**

It is certified that, "Bovine Spongiform encephalopathy (BSE) is not reported in Bangladesh. The products described above have been derived from the Bangladeshi Bull, Further these products have not been derived from the material associated with the products imported from BSE/TSE affected countries.
