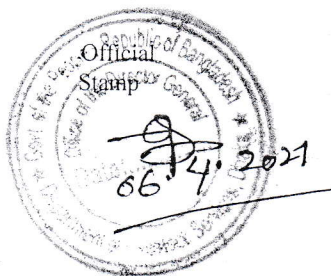

There is no outbreak of BSE (Bovine Spongiform Encephalopathy) in Bangladesh and accordingly Bone Gelatin (B-Type) is free from BSE (Bovine Spongiform Encephalopathy)/ Mad Cow disease and absolutely fit for human consumption. Herewith also Certify that Gelatin (B-Type) which was examined in Central Disease Investigation Laboratory (CDIL), Dhaka under the Directorate of Research, Training & Evaluation of Department of Livestock Services and found no Bacillus anthracis (Anthrax), Mycobacterium spp. (Tuberculosis), FMD virus, Bovine Babesiosis, E.Coli, Salmonella spp and Fungus were identified from supplied Gelatin-B type (GIC007, GIC008, GIC009, GIC010, GIC011, GIC012, and GIC013.) samples during the period of examination (report no-547 date: 05.04.2021).
