
**CERTIFICATION:**

In so far as can be determined and based on the written declaration of the exporter I the undersigned official Veterinarian certified that the material:

1. Contains bovine penis (pizzles) as the only animal origin.
2. Produced only in Bangladesh.
3. Material: derived only from bovines that: (a) have never been fed ruminant-derived meat-and-bone meal and greaves, AND (b) were not subjected to a pitching process or a stunning process using a device injecting compressed air or gas into the cranial cavity.
4. Heated to a temperature of 80<sup>0</sup> C for 60 minutes.
5. The product has been tested at Quality Control Laboratory (QC-Lab), Saver, Dhaka of DLS and found negative for *Salmonella spp.* according certificate of Analysis (Report no: QCLab\_DLS\_22100057; Date: 02/11/2022) during the period of examination.


