CERTIFICATION:

In so far as can be determined and based on the written declaration of the exporter I the undersigned official Veterinarian certified that the material:

1. Contains a bovine penis (pizzles) as the only animal origin.
2. Produced only in Bangladesh.
3. Material: derived only from bovines that: (a) have never been fed ruminant-derived meat-and-bone meal and greaves, AND (b) were not subjected to a pitching process or a stunning process using a device injecting compressed air or gas into the cranial cavity.
4. Heated to a temperature of 85⁰ C for 5 hours.
5. The product has been tested at the Quality Control Laboratory (QC-Lab), Savar, Dhaka, under the Department of Livestock Services (DLS) and found negative for Salmonella spp. according to the Certificate of Analysis. (Report No: QCLab_DLS_22110034, date: 01/12/2022).
6. This certificate is valid for 90 days


