1. Contains bovine penis (pizzles) as the only animal origin.

2. Produced only in Bangladesh.


3. Material: derived only from bovines that: (a) have never been fed ruminant derived meat-and-bone meal and greaves, AND (b) were not subjected to a pitching process or a stunning process using a device injecting compressed air or gas into the cranial cavity.

4. Heated to a temperature of 80⁰ C for 60 minutes.

5. The product has been tested at Quality Control Laboratory (QC-Lab), Savar, Dhaka, under the Directorate of Livestock Services (DLS) and found negative for Salmonella spp. & other Enterobacter spp. (E. Coli) were found from the collected Pet Chews/ Pizzle during the period of examination according to the report no: QCLab_DLS_22120019 date- 22- Dec-2022.
