

The feathers are cleaned with Detergent, dry, and free of blood stains, faces and evident skin pieces. 4. The product has been tested at Quality Control Laboratory (QC-Lab), Savar, Dhaka under the Department of Livestock Services (DLS) and found negative for Salmonella spp. according to the Certificate of Analysis.
