The milk products (Sweetened yogurt) are only of animal origin and produced in Bangladesh. 2. Liquid milk of Sweetened yogurt heated by 150⁰ C - 200⁰ C for 3-4 hours. 3. The milk products (Sweetened yogurt) are the only animal-origin ingredient and were heated to a temperature of 72⁰c for 15 seconds followed by a second heating to a temperature of 72⁰c for 15 seconds and a single pasteurization of 72⁰c for 15 seconds followed by a pH treatment of less than 6 for one hour prior to exportation to the United States. 4. The product has been tested at Quality Control Laboratory (QCL) Savar, Dhaka under the Department of Livestock Services (DLS) and found negative for E. Coli and Salmonella, fungus within permissible limit according to the certificate of Analysis (Report No: QCLab_DLS_23020012, Date: 16-02-2023) during the period of examination. 5. This certificate is valid for 90 days from the date of issue.
