
CERTIFICATION:

In so far as can be determined and based on the written declaration of the exporter I the undersigned official Veterinarian certified that the material:

1. Contains bovine penis (pizzles) as the only animal origin. The product is dried and has no other animal product or by- product.
2. Produced only in Bangladesh.
3. Material: derived only from bovines that: (a) have never been fed ruminant derived meat-and-bone meal and greaves, AND (b) were not subjected to a pitching process or a stunning process using a device injecting compressed air or gas into the cranial cavity.
4. Every precaution was taken to avoid cross-contamination of the finished product with any animal origin product or by-product derived from animals of a lesser zoo sanitary status.
5. The Pet chews are packaged in new packing materials
6. Exported Product Heated to a minimum internal temperature of 85±C for 5 hours.
7. The product has been tested at Quality Control Laboratory (QC Lab) under the Department of Livestock Services (DLS) and found negative for Salmonella spp. & and found Enterobacteriaceae within permissible limit according to certificate of Analysis (Report No: QCLab_DLS_23020044 Date: 02-03-2023) during the period of examination.
8. This certificate is valid for 90 days

BSE FREE CERTIFICATION

It is certified that "Bovine Spongiform encephalopathy (BSE) is not reported in Bangladesh. The products described above have been derived from the Bangladeshi Bull, Further, these products have not been derived from the material associated with the products imported from BSE/TSE-affected countries, though importation of live cattle, buffalo, sheep and goat bovine, ovine and caprine embryo/oval fresh meat, meat products tissue/organs, meat and bone meal of ruminants origin into Bangladesh.
