In so far as can be determine and based on written declaration of the exporter I, the undersigned official Veterinarian certified that the material:

1. Contains bovine penis (pizzle) as the only animal origin material.
2. Produced only in Bangladesh.
3. Contains bovine material: derived only from bovines that: (a) have never been fed ruminant derived meat-and-bone meal and greaves, AND (b) were not subjected to a pitling process or a stunning process using a device injecting compressed air or gas into the cranial cavity.
4. Was heated to a minimum internal (core) temperature of 80° C.
5. Was produced and handled in a manner to ensure that such commodities were not commingled with any animal origin material not authorized by this permit including ruminant meat-and-bone meal, or greaves APHIS-defined SRMS and mechanically separated meat derived from the skull and vertebral column of bovines 30 months of age or older from APHIS-defined controlled risk regions or bovines over 12 months of age from APHIS-defined undetermined risk regions.
6. The product has been tested at Quality Control Laboratory (QC-Lab) Savar, Dhaka, under the Department of Livestock Services (DLS) and found negative for Salmonella spp. according to the report No.QCLab_DLS_23040028, Date- 17/04/2023.
7. This certificate is valid for 90 days.

It is certified that, "Bovine Spongiform encephalopathy (BSE) is not reported in Bangladesh. The products described above have been derived from the Bangladeshi Bull, Further these products have not been derived from the material associated with the products imported from BSE/TSE affected countries, though importation of live cattle, buffalo, sheep and goat, bovine, ovine and caprice embryo/oval fresh meat, meat products tissue/organs, meat and bone meal of ruminants origin into Bangladesh.
