1. Contains bovine penis (pizzles) as the only animal origin.
2. Produced only in Bangladesh.
3. Material: derived only from bovines that: (a) have never been fed ruminant derived meat-and-bone meal and greaves, AND (b) were not subjected to a pitching process or a stunning process using a device injecting compressed air or gas into the cranial cavity.
4. Heated to a temperature of 80⁰ C for 60 minutes.
5. The product has been tested at Central Disease Investigation Laboratory (CDIL) Dhaka, under the Directorate of Research, Training & Evaluation of DLS and found negative for Salmonella spp. according to the (Report No. 178 date- 02/02/2021).
