
**CERTIFICATION:**

In so far as can be determined and based on the written declaration of the exporter I the undersigned official Veterinarian certified that the material:

1. Contains bovine penis (pizzles) as the only animal origin. Produced only in Bangladesh.
2. Material: derived only from bovines that: (a) have never been fed ruminant-derived meat-and-bone meal and greaves, AND (b) were not subjected to a pitching process or a stunning process using a device injecting compressed air or gas into the cranial cavity.
3. Heated to a temperature of 85<sup>0</sup> C for at least 5 hours.
4. The product has been tested at the Quality Control Laboratory (QC-Lab), Savar, Dhaka Under the Department of Livestock Services (DLS) and found negative for Salmonella spp. & within permissible limit of Enterobacteriaceae according to the Certificate of Analysis. (Report No: QCLab\_DLS\_23010055, Date-22/01/2023).
5. This certificate is valid for 90 days

**BSE FREE CERTIFICATION**

It is certified that "Bovine Spongiform encephalopathy (BSE) is not reported in Bangladesh. The products described above have been derived from the Bangladeshi Bull, Further, these products have not been derived from the material associated with the products imported from BSE/TSE-affected countries, though importation of live cattle, buffalo, sheep and goat, bovine, ovine and caprine embryo/oval fresh meat, meat products tissue/organs, meat and bone meal of ruminants origin into Bangladesh.
