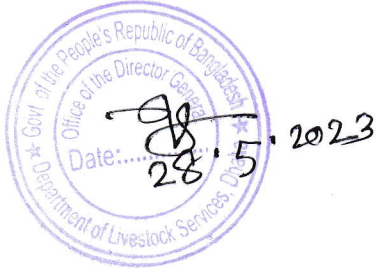

The undersigned Official Veterinarian certifies that the products described above satisfy (ies) the following requirements:

1. The poultry which washed feather derived are born and raises in exporting country. No poultry are contained or killed for epidemic disease reasons.
2. The raw feather material should be originated from abattoir which under the supervision of exporting country competent authority.
3. The feather washed, then dried at a temperature of 120°C for at least of 30 minutes, or treated with hot stream of 100°C for at least of 30 minutes.
4. Washed feathers are clean, dry, free of blood stains, faces and evident skin pieces.
5. Oxygen consumption $\leq 5.6\text{mg}/100\text{g}$, transparency $\geq 500\text{mm}$.
6. The product has been tested at Quality Control Laboratory (QC-Lab), Savar, Dhaka under the Department of Livestock Services (DLS) and found negative for Salmonella spp. according to the Certificate of Analysis. (Report No: QCLab_DLS_23040047, Date-11/05/2023).
7. This certificate is valid for 90 days
