1. Contains dried bull pizzle as the only animal origin.
2. Produced only in Bangladesh.
3. Material: derived only from bovines that: (a) have never been fed ruminant derived meat-and-bone meal and greaves, AND (b) were not subjected to a pitching process or a stunning process using a device injecting compressed air or gas into the cranial cavity.
4. Heated to a temperature of 90<sup>o</sup> C for 4 Days.
5. The product has been tested at Quality Control Laboratory (QC-Lab), Savar, Dhaka Under the Department of Livestock Services (DLS) and found no Salmonella spp. & other Enterobacter spp. (E.
