In so far as can be determined and based on written declaration of the exporter I, the undersigned official veterinarian certified that the material:

1. Contains dried bull pizzle as the only animal origin.
2. Produced only in Bangladesh.
3. Material: derived only from bovines that: (a) have never been fed ruminant derived meat-and-bone meal and greaves, AND (b) were not subjected to a pitching process or a stunning process using a device injecting compressed air or gas into the cranial cavity.
4. Heated to a temperature of 90^o C for 4 Days.
5. The product has been tested at Quality Control Laboratory (QC-Lab), Savar, Dhaka Under the Department of Livestock Services (DLS) and found no Salmonella spp. & other Enterobacter spp. (E. Coli) according to the Certificate of Analysis. (Report No: QCLab_DLS_23030030 Date: 29/03/2023) during the period of examination.
