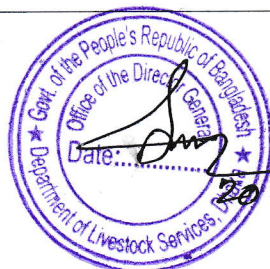

**CERTIFICATION:**

In so far as can be determined and based on written declaration of the exporter I, the undersigned official veterinarian certified that the material:

1. Contains bovine penis (pizzles) as the only animal origin.
2. Produced only in Bangladesh.
3. Material: derived only from bovines that: (a) have never been fed ruminant derived meat-and-bone meal and greaves, AND (b) were not subjected to a pitching process or a stunning process using a device injecting compressed air or gas into the cranial cavity.
4. Heated to a temperature of 80<sup>0</sup> C for 60 minutes.
5. The product has been tested at Quality Control Laboratory (QC-Lab), Savar Dhaka under the Department of Livestock Services DLS and found no Salmonella spp. according to the Certificate of Analysis. (Report No: QC Lab\_DLS\_23060030 Date: 15/06/2023) during the period of examination.
6. This certificate is valid for 90 days.
