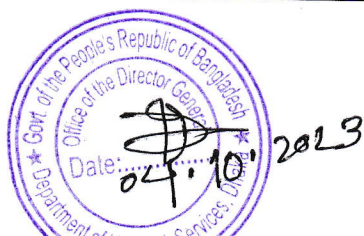

**CERTIFICATION:**

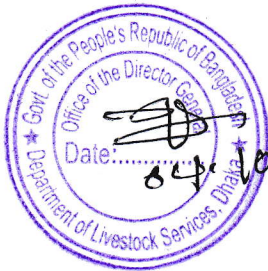
In so far as can be determine and based on written declaration of the exporter I, the undersigned official veterinarian certified that the material:

1. Contains bovine penis (pizzles) as the only animal origin.
2. Produced only in Bangladesh.
3. Derived only from bovines that: (a) have never been fed ruminant derived meat-and-bone meal and greaves, AND (b) were not subjected to a pitching process or a stunning process using a device injecting compressed air or gas into the cranial cavity.
4. Heated to a temperature of 90<sup>0</sup> C for 60 minutes.
5. The product has been tested at Quality Control Laboratory (QC-Lab), Savar, Dhaka, under the Department of Livestock Services (DLS) and found negative for Salmonella spp. were found from the collected Pet Chews/ Pizzle during the period of examination according to the report no: QCLab\_DLS\_22090083 Date: 01/10/2023.
