CERTIFICATION:

In so far as can be determined and based on written declaration of the exporter I, the undersigned official veterinarian certified that:

1. The milk products (Sweetened yogurt) are only animal origin and produced in Bangladesh.
2. Liquid milk of Sweetened yogurt heated by 150 °C - 200 °C Through Vaporization.
3. The milk products (Sweetened yogurt) are the only animal origin ingredient and was heated to temperature of 72 °c for 15 seconds followed by a second heating to temperature of 72 °c for 15 seconds and a single pasteurization of 72 °c for 15 seconds followed by a pH treatment of less than 6 for one hour prior to exportation to the Singapore.
4. The product has been tested at Quality Control Laboratory (QCL) Savar, Dhaka under the Department of Livestock Services (DLS) and found negative for E. Coli, Salmonella, and found fungus within permissible limit according to the certificate of Analysis (Report No: QCLab_DLS_23090058, Date: 24-09-2023) during the period of examination.
5. This certificate is valid for 90 days from the date of issue.
