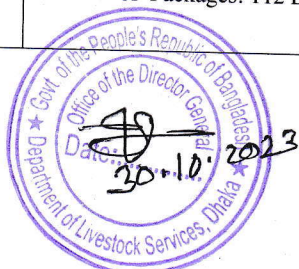

The feather washed, then dried at a temperature of 120°C for a least of 30 minutes, or treated with hot stream of 100°C for at least of 30 minutes.4. Washed feathers are clean, dry and free of blood stains, faces and evident skin pieces.5. Oxygen consumption $\leq 5.6\text{mg}/100\text{g}$, transparency $\geq 500\text{mm}$.6. The product has been tested at Quality Control Laboratory (QC-Lab), Saver Dhaka under the Department of Livestock Services (DLS) and found no Salmonella spp. identified in supplied Cleaned duck feather samples during the period of examination according to the (Report No. QCLab_DLS_23080040 Date: 24/08/2023).7.
